Redesigning Law in the AI Age: From Legacy to Legitimacy

Now in its fifth edition, IE Lawtimation Days has become what participants consistently describe as a not-to-miss fixture in the academic calendar, **a permanent centre of gravity** known for the quality of its contributions, its cross-generational and cross-disciplinary exchange, and an atmosphere that is rigorous and collegial.

This year's conference confronts a central challenge: how to move from legacy to legitimacy.

The regulatory wave of the early 2020s is now giving way to implementation, recalibration and the pressure to simplify without hollowing out rights. **Law is being redesigned:** norms translated into standards, operationalized through compliance, litigated before courts and embedded in technical models. The question is whether better-designed, more effectively enforced laws might achieve more. Beyond diagnosis, we aim to develop responses that are intellectually rigorous, truly actionable and attuned to real-world needs.

Practical information

The conference will take place in **Madrid, Spain, at the IE Tower** (also known as CALEIDO), located on Paseo de la Castellana 259E, 28046 Madrid. Directions can be found **[here](#)**.

Metro | The closest Station is **Begoña** (Line 10). After you get off the train, follow the exit signs leading to Cuatro Torres Business Area. Once on the street, walk toward the skyscrapers and look for the tower with the IE logo.

 *Note: Line 10 is currently affected by works at Santiago Bernabéu station, with Cuzco–Nuevos Ministerios remaining closed through the end of 2026. If you are coming from the south (city centre), take Line 10 to Plaza de Castilla (or use the free replacement bus/reinforced Lines 1 or 9 if that stretch is also cut) and continue north to Begoña from there. If you are coming from the north, service to Begoña is unaffected.*

Taxi & Ridesharing | If you come by taxi or ridesharing, the most convenient drop-off location is the main entrance of the Moeve Tower (formerly known as Cepsa Tower). Once there, do not enter the building. Instead, walk around the building to reach the IE Tower in less than 3 minutes.

Other Transportation | Depending on your hotel's location, you may want to consider alternative transportation options, such as e-bikes or bus lines. **Citymapper** is a useful transit app for navigating around Madrid.

Once at the Tower, proceed to the reception desk to check in and for information on how to **reach floor 24**.
